

SEEFA Member Briefing April 2017

We thought SEEFA members might appreciate another short written briefing. - 1. Symposium: Our ageing society challenges and opportunities for business'. Following the Policy Panel on 31st October 2016 where we identified key issues on the subject of business responses to an ageing society, we held a major event, a Symposium, at the House of Lords on 20th March 2017. This was part of the joint project with South East Age UKs, aiming to improve the experience of older consumers. At the Symposium we examined the subject from different perspectives in a debate hosted by Lord Filkin and chaired by David Brindle. A summary of the event is available. Further work on this will take place and we hope people will take the issues forward in their neighbourhoods and organisations.
- Launch of EngAgeNet. The new independent England-wide body EngAgeNet, the English Age Network, was launched on 20th March in the House of Lords. The website is: www.EngAgeNet.org.uk. - 3. SEEFA's work to improve Housing. Response to the Housing White paper. We have responded to the call for views, drawing attention to the unmet housing need in the light of an ageing population. We have met with the Department of Health, Cabinet Office and DCLG on this and we are working with Care and Repair and the Housing Champions to push forward the case for better, more suitable housing and greater engagement with older people. A body of evidence is now emerging which links health benefits to good housing. For further information on this please contact me.
- 4. **Policy Panel on Later Life and Ageing**. On 19th January 2017 the Policy Panel on later Life and Ageing met to consider how people of all generations can work together to make later life better for everyone. We developed our key issues and these can be used in discussions with policy makers. We'll be exploring this theme further and plan to hold a Convention on the subject.

As previously mentioned, we'd like to extend Policy Panel membership and to ensure we have as wide and diverse a range of views as we can. In particular we'd like to invite members who do not normally have the opportunity to speak out e.g. those in residential care, people with dementia and people from under-represented groups. If you have any suggestions please let us know.

5. Later Life Digital Inclusion. Mike's work in Brighton is continuing. If you'd like to know more please contact Mike: <u>mike_bojczuk@yahoo.co.uk</u>. We are still of the view that

digital exclusion is a major problem and one which has not been recognised by government and businesses. We'll continue to take this strand of work forward through our work on the challenges and opportunities for business of an ageing society.
